

ASSIGNMENT - UNITED STATES TRADEMARKS

AND, Assignor further covenants and agrees that it will, upon request and at Assignee's expense, promptly provide the Assignee with all pertinent facts and documents relating to said trademarks, trademark applications and rights as may be known and accessible to the Assignor and will testify to the same in any interference or litigation relating thereto and will promptly execute and deliver to

the Assignee or its legal representative any and all papers, instruments or affidavits required to apply for, obtain, maintain, issue and enforce, said trademarks and applications and said rights which may be necessary or desirable to carry out the purposes thereof.

AND, Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks to record Assignee as assignee of the entire interest and owner thereof, and hereby covenants that it has full right to convey the entire interest herein assigned, and that it has not executed, and will not execute, any agreements inconsistent herewith.

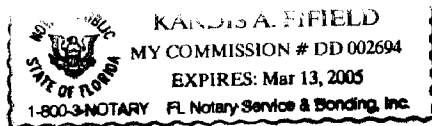
