
WHEREAS, ASSIGNEE desires to have a recordable document evidencing title to said trademark properties.

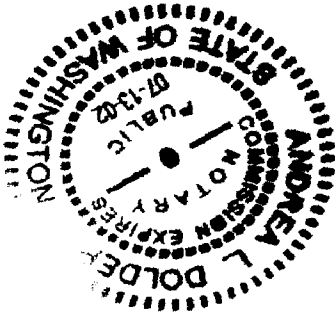
