ASSIGNMENT

(Trademark Application)

WHEREAS, Intershoe, Inc., a corporation organized under the laws of the State of New York with an address at 57 Seaview Boulevard, Port Washington, New York 11050, (hereinafter called the "Assignor") has adopted and uses JAZZ, which is registered in the United States Patent and Trademark Office, Registration No. 1,185,867 dated January 12, 1982 (the "Trademark"); and

WHEREAS, J & L Footwear, Inc., a corporation organized under the laws of the State of California and having offices at 6080 Triangle Drive, Commerce, California 90040, (hereinafter called the "Assignee") is desirous of acquiring the right, title and interest in and to the aforesaid Trademark and registration thereof, and the goodwill of the business or part thereof connected with and symbolized by the said Trademark; and

WHEREAS, Assignor and Assignee have entered into, as of the date hereof, a certain Trademark Purchase and Sale Agreement (the "Agreement") in respect to the Trademark;

NOW, THEREFORE, for good and valuable consideration, including but not limited to, the Agreement, the receipt and sufficiency of which is hereby acknowledged by the parties;

(a) Assignor by these presents does hereby sell, assign and transfer onto the said Assignee, its successors and assigns, all rights, title and interest in and to the said Trademark, together with any and all goodwill symbolized by said Trademark and of the business connected with the use of and symbolized by said Trademark and any part thereof; and any income, royalties, damages and payments now or hereafter due or payable in respect thereto; and any and all causes of action, either in law or in equity, for past, present, or without limitation, corresponding to the foregoing throughout the United States, its Territories and Commonwealths.
