ASSIGNMENT NUNC PRO TUNC

THIS ASSIGNMENT is between Wisconsin Cheese, Inc., a corporation organized and existing under the laws of the State of Illinois, having a place of business at 1931 N. 15th Ave., Melrose Park, Illinois 60160, (hereinafter sometimes referred to as "Wisconsin Cheese") and Wiscon Corporation, a corporation organized and existing under the laws of the state of Illinois, having a place of business at 777 Bank Lane, Lake Forest, Illinois 60045 (hereinafter sometimes referred to as "Wiscon").

WHEREAS, Wisconsin Cheese is the owner of the entire right, title and interest in and to a US trademark registration for the mark SUPLENTE, Reg. No. 1,849,497, together with the goodwill associated therewith; and Wisconsin Cheese is desirous of transferring and assigning its entire right, title and interest to the aforesaid trademark registration together with the goodwill associated therewith to Wiscon and Wiscon is desirous of acquiring the same;

THEREFORE, in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, the parties agree as follows:

Wisconsin Cheese hereby transfers and assigns to Wiscon its entire right, title and interest in and to U.S. Trademark Reg. No. 1,849,497 for the mark SUPLENTE including the goodwill associated therewith and the right to file suit and recover for any past infringement thereof.

This trademark assignment shall be considered effective at least as early as the filing date of the Section 8 & 15 declaration previously executed and subsequently submitted to the U.S. Patent and Trademark Office for filing, or September 12, 2000.
