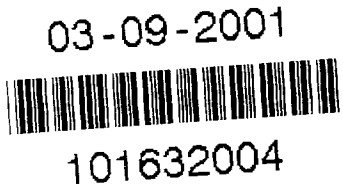

TRADEMARK APPLICATION ASSIGNMENT

WHEREAS, USMoving.com, Inc., a Delaware corporation ("Assignor"), is the owner of the trademarks and trademark applications in the form more fully described in Exhibit A hereto (the "Property");

2. At any time and from time to time from the date hereof, Assignor agrees, at Assignee's request and without further consideration, to execute and deliver such instruments of sale, transfer, conveyance, assignment and confirmation, and to perform any other reasonable acts Assignee may reasonably request in order to more effectively sell, transfer, convey and assign to Assignee all of Assignor's right, title, and interest in and to the Property.

This Trademark Assignment shall be governed by and construed in accordance with the laws of the State of New York.

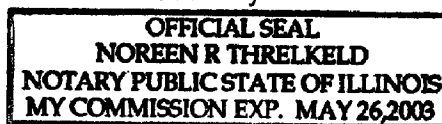
