**LIMITED RELEASE OF SECURITY INTEREST**

THIS LIMITED RELEASE OF SECURITY INTEREST (this "Release") is granted by Foothill Capital Corporation, a California corporation ("Foothill"), with its principal place of business and mailing address at 2450 Colorado Avenue, Suite 3000 West, Santa Monica, California 90404, with regard to an Intellectual Property Security Agreement, dated as of July 26, 2000 (the "IP Security Agreement"), between Epicor Software Corporation, a Delaware corporation ("Epicor"), with its principal place of business and mailing address at 195 Technology Drive, Irvine, California 92618, and Foothill.

WHEREAS, to secure performance of the obligations of Epicor as set out in the IP Security Agreement, Epicor granted Foothill a security interest in certain trademark rights;

WHEREAS, a Security Interest in Trademarks, dated as of July 26, 2000, by Epicor in favor of Foothill, was filed and recorded in the United States Patent and Trademark Office ("PTO") on August 30, 2000, at Reel No. 002141, Frame No. 0505, to evidence the security interest granted Foothill under the IP Security Agreement;

WHEREAS, Epicor has requested that Foothill: (a) release the liens and interests of Foothill with respect to a certain trademark; and (b) execute and deliver evidence of such release for filing in the PTO and pursuant to the Uniform Commercial Code; and

WHEREAS, Foothill has agreed to such release;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Foothill hereby releases Foothill's security interest in the following trademark and all of Epicor's rights with respect thereto:
