of the State of New York

We, the undersigned, being the vice president and
treasurer and an assistant secretary, respectively, of CBS Inc.,
hereby certify that:

FIRST: The name of the Corporation is CBS Inc. The
name under which the Corporation was formed is United Independent
Broadcasters, Incorporated.

SECOND: The original Certificate of Incorporation of
said Corporation was filed by the Department of State of the
State of New York on January 27, 1927 and was most recently
restated on December 8, 1995.

THIRD: Article 1 of the Certificate of Incorporation,
which specifies the name of the Corporation, is hereby amended to
read as follows:

"The name of the Corporation is CBS Broadcasting
Inc."

FOURTH: The last sentence of Article 5 of the
Certificate of Incorporation, which specifies the address to
which the Secretary of State shall mail a copy of process against
the Corporation served upon the Secretary of State, is hereby
amended as follows:

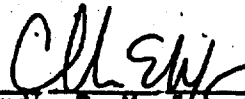
"The post office address within or without the

sole shareholder dated November 11, 1997.

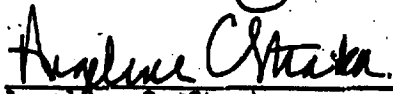

UNDER SECTION 805 OF THE BUSINESS CORPORATION LAW

WE, THE UNDERSIGNED, Louis J. Briskman and Clare McMorro-Castro, being respectively the Executive Vice President and an Assistant Secretary of CBS Broadcasting Inc., hereby certify:

1. The name of the corporation is: CBS Broadcasting Inc.
2. The certificate of incorporation of said corporation was filed by the Department of State on the twenty-seventh day of January, 1927.
3. (a) The certificate of incorporation is amended to increase the number of authorized shares.

(b) To effect the foregoing, Article 3 relating to the authorized shares of the corporation is amended to read as follows:

3. The aggregate number of shares which the Corporation shall have authority to issue is five thousand (5,000), all of which are of \$0.01 par value and are of the same class and are designated as common shares.

4. The amendment was authorized by the Unanimous Written Consent of the corporation's board of directors and by the Shareholder Action of the corporation's sole shareholder.
