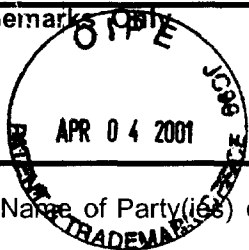

**ASSIGNMENT OF PENDING U.S. TRADEMARK APPLICATION**

WHEREAS, CONTINENTAL ELECTRONICS CORPORATION, a corporation organized and existing under the laws of the State of Nevada, and having its principal place of business at 4212 S. Buckner Blvd., P. O. Box 270879, Dallas, TX 75227 (hereinafter called "CONTINENTAL") is the owner of the entire right, title and interest in and to the trademark SPECTRASTAR, for television transmitters, as covered by intent-to-use U.S. Trademark Application Serial No. 76/017,776, filed April 5, 2000.
