

**ARTICLES OF AMENDMENT  
TO THE ARTICLES OF INCORPORATION  
OF  
ESI ACQUISITION CORPORATION**

Pursuant to the provisions of Sections 10-1005 and 10-1006 of the Arizona Revised Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- FIRST:** The name of the corporation is ESI Acquisition Corporation.
- SECOND:** Article 1 of the Articles of Incorporation of ESI Acquisition Corporation is amended to read as follows:
 

**Article 1**

The name of the Corporation is Expert Systems, Inc. OLMF
- THIRD:** The amendment does not provide for an exchange, reclassification or cancellation of issued shares.
- FOURTH:** The amendment was adopted on February 19, 1997.
