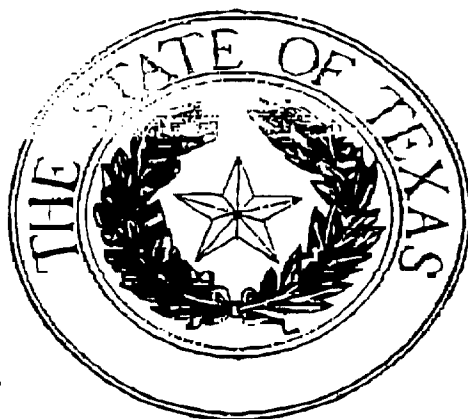

**ARTICLES OF AMENDMENT  
TO THE  
ARTICLES OF INCORPORATION**

Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation.

**ARTICLE ONE**

The name of the corporation is Princeton Medical Management Resources, Inc.

The following amendment was adopted by the shareholders of the corporation of the 28th day of December, 1998:

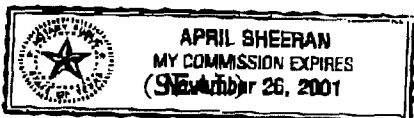
