ASSIGNMENT OF TRADEMARKS

WHEREAS, DENTRIX DENTAL SYSTEMS, INC., a Utah corporation having a principal place of business at 727 E. ASSIGNOR, does also hereby sell, assign, transfer and set over unto ASSIGNEE, its successors, legal representatives and assigns all claims for damages by reason of past infringement of the TRADEMARKS, the right to sue for and collect the same for its own use and enjoyment and for the use and enjoyment of its successors, assigns, or other legal representative;


ASSIGNOR further authorizes the Commissioner of Patents and Trademarks of the United States, to record said assignment so as to show ownership of the TRADEMARKS in HSI SERVICE CORP., the Assignee; and

ASSIGNOR further agrees to execute such further documents as may be required to record ASSIGNEE as the owner of the TRADEMARKS and registrations herein assigned.
