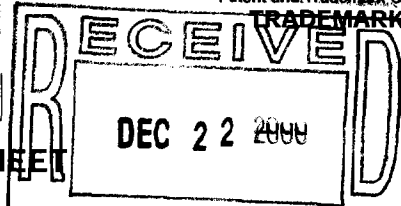

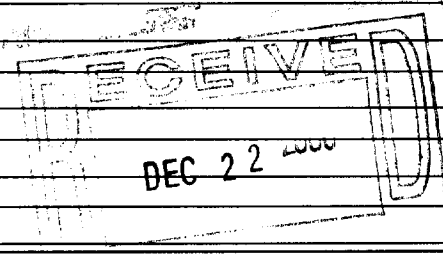

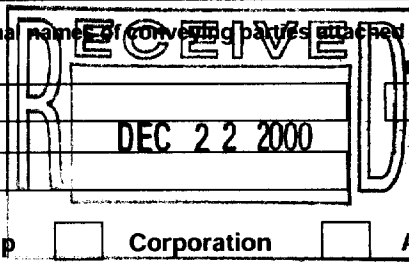

1. That pursuant to the written consent of the Board of Directors and a unanimous vote of the sole shareholder of the issued and outstanding stock of the corporation, resolutions were adopted approving the deletion of Article I of the Certificate of Incorporation and the insertion of the following in place thereof:
