

ASSIGNMENT OF TRADEMARK

WHEREAS, CANNONDALE CORPORATION (hereinafter called "Assignor"), is the owner of the trademark "Dirt Camp" for use in connection with mountain biking camps and merchandise associated therewith (the "Trademark"); and

WHEREAS, Assignor has entered into an Asset Purchase Agreement dated as of June 30, 1997, by and among the Assignor, Dirt Camp, Inc. ("Dirt Camp"), a wholly owned subsidiary of Assignor and DAVEDAN, INC., a Connecticut corporation (hereinafter called "Assignee"), whereby Assignor and Dirt Camp have agreed to transfer to Assignee certain assets relating to the business of operating recreational mountain biking camps, which assets include the Trademark.

NOW, THEREFORE, in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt of which is hereby acknowledged:

- 1. Assignor does hereby SELL, ASSIGN, TRANSFER and SET OVER unto Assignee TO HAVE AND TO HOLD FOREVER, all right, title and interest in and to the Trademark (all versions, including stylized and block text), together with the goodwill of the business symbolized thereby, and the right to sue and collect damages for past infringement thereof, and the registrations and applications to register the Trademark listed in Exhibit A hereto.
- 2. Assignor hereby agrees to execute, or cause to be executed, any and all further instruments, documents, agreements and affidavits which may be necessary or desirable to vest, perfect, maintain or defend the interest of Assignee, its successors and assigns, in and to the Trademark, and to cooperate fully with Assignee, at Assignee's expense, in the prosecution of any claims for past infringement of the Trademark, including but not limited to participating as a named plaintiff, if necessary.
- 3. This Assignment and the covenants and agreements herein contained shall inure to the benefit of Assignee and its successors and assigns, and shall be binding upon Assignor, and its successors and assigns.
