GRANT OF SECURITY INTEREST

TRADEMARKS

THIS GRANT OF SECURITY INTEREST, dated as of September 12, 2000, is executed by Applied Science Fiction, Inc., a Delaware corporation ("Debtor"), in favor of CenterPoint Venture Partners L.P., as collateral agent ("Collateral Agent").

A. Pursuant to a Note Purchase Agreement, dated as of September 8, 2000 (the "Note Purchase Agreement"), among Debtor and certain Secured Parties, such Secured Parties have agreed to extend certain credit facilities to Debtor upon the terms and subject to the conditions set forth therein.

B. Debtor has adopted, used and is using the trademarks, more particularly described on Schedules 1-A and 1-B annexed hereto as part hereof, which trademarks are registered or subject to an application for registration in the United States Patent and Trademark Office (collectively, the "Trademarks");

C. Debtor has entered into an Intellectual Property Security Agreement dated the date hereof (as amended, modified or otherwise supplemented from time to time, the "Security Agreement") in favor of Collateral Agent; and

D. Pursuant to the Security Agreement, Debtor has granted to Collateral Agent a security interest in all right, title and interest of Debtor in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks and the customer lists and records related to the Trademarks and the applications and registrations thereof, and all proceeds thereof, including any and all causes of action which may exist by reason of infringement thereof (the "Collateral"), to secure the payment, performance and observance of the Obligations, as defined in the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Debtor does hereby further grant to Collateral Agent a security interest in the Collateral to secure the prompt payment, performance and observance of the Obligations.






