ASSIGNMENT OF TRADEMARKS

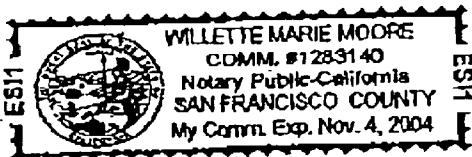
