

RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (“Release”) is made as of February 26, 2001, by SANWA BANK CALIFORNIA, a California corporation located at 1280 Fourth Avenue, San Diego, California 92101 (“Secured Party”), in favor of PUREPULSE TECHNOLOGIES, INC., a Delaware corporation located at 4241 Ponderosa Avenue, San Diego, California 92123 (“Company”).

W I T N E S S E T H:

WHEREAS, Company executed that certain Security Agreement dated October 25, 2000 (“Security Agreement”), pursuant to which Company granted a security interest to Secured Party in, among other things, certain intellectual property owned by Company, and

WHEREAS, Company executed that certain Assignment of Security Interest in United States Trademarks, dated October 25, 2000 (“Assignment of Security Interest”), pursuant to which Company granted a security interest to Secured Party in, among other things, certain intellectual property owned by Company; and

Secured Party releases, without recourse or warranty, and reconveys to Company, all its right, title, claim and interest in and to the Released Collateral, all rights corresponding thereto, including but not limited to, all renewals, and extensions thereof, and the recordings and applications therefor.


2. Secured Party hereby represents and warrants that it has not transferred any rights in the Released Collateral to any other party.
