**INTELLECTUAL PROPERTY**

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY ("Release") is made as of February 26, 2001, by SANWA BANK CALIFORNIA, a California corporation located at 1280 Fourth Avenue, San Diego, California 92101 ("Secured Party"), in favor of MAXWELL ELECTRONICS COMPONENTS GROUP, INC., a California corporation located at 9244 Balboa Avenue, San Diego, California 92123 ("Company").

W I T N E S S E T H:
