## ASSIGNMENT OF TRADEMARKS AND TRADEMARK APPLICATIONS

THIS ASSIGNMENT ("Assignment") effective as of August 28, 2000 is entered into by COMERICA BANK-CALIFORNIA ("Assignor") and COMERICA BANK, AS AGENT, Michigan banking corporation and having a principal place of business at One Detroit Center, 500 Woodward Avenue, Detroit, Michigan 48226 ("Assignee").

WHEREAS, under a certain Credit Agreement dated October 30, 1998 by and between A&J Cheese Company ("Grantor") and Comerica Bank-California, as Secured Party, Comerica Bank-Comerica as Secured Party agreed to extend credit facilities to Grantor; and,

WHEREAS, as a condition of Comerica Bank-Comerica as Secured Party's extension of Credit to Grantor, Grantor agreed to grant to Comerica Bank-Comerica as Secured Party a security interest in certain collateral as security for the payment and performance of Grantor's obligations under the Credit Agreement and related documents; and

WHEREAS, pursuant to a Patent, Trademark and Copyright Security Agreement dated October 30, 1998 (the "Security Agreement"), Grantor assigned to Comerica Bank-Comerica as Secured Party a security interest in all of Grantor's right, title and interest in certain intellectual property; and

WHEREAS, Comerica Bank-California has resigned as Agent under the Credit Agreement and desires to assign to Assignee as successor agent under the Credit Agreement all of its rights and obligations under the Security Agreement to Assignee, and Assignee desires to accept such assignment, all on the terms and subject to the conditions set forth in the Security Agreement.


NOW THEREFORE, in consideration of the premises, Assignor and Assignee agree as follows:
