ASSIGNMENT OF TRADEMARKS AND GOODWILL

WHEREAS, THE CLOROX COMPANY, a corporation organized under the laws of the State of Delaware, U.S.A., domiciled at 1221 Broadway, Oakland, California 94612, United States of America, hereinafter referred to as CLOROX, is the sole and exclusive owner of the trademarks and Certificates of Trademark Registration indicated on **Exhibit A** hereto, and of the goodwill of the business carried on by it in connection with said trademarks; and,

WHEREAS, THE GLAD PRODUCTS COMPANY, a corporation organized under the laws of the State of Delaware, U.S.A., domiciled at 1221 Broadway, Oakland, California 94612, United States of America, hereinafter called GLAD, is desirous of acquiring said trademarks and Certificates of Trademark Registration, together with the goodwill of the business heretofore carried on by CLOROX in connection with said trademarks.

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) and for other good and valuable consideration receipt whereof in full is hereby acknowledged:

1. CLOROX hereby sells, assigns and transfers to GLAD, its successors, assigns and other legal representatives, the entire right, title and interest in and to said trademarks, said Certificates of Trademark Registration, and the goodwill of the business heretofore carried on by CLOROX in connection with said trademarks, together with all claims, demands and causes of action for the past infringement of any or all said trademarks and registrations or for unfair competition in business in connection therewith wheresoever or by whomsoever committed; the same to be held and enjoyed by GLAD, its successors, assigns or other legal representatives as fully and entirely as the same would or could have been held and enjoyed by CLOROX had this assignment and sale not been made.
2. CLOROX warrants, covenants and represents the fact to be that it is the owner of said trademarks and Certificates of Trademark Registration, that it has not heretofore granted any license, right or privilege or in any other way encumbered the same, and that it has the full right to convey, free of all licenses and encumbrances, the entire interest hereby assigned.

3. The trademarks and Certificates of Trademark Registration hereby assigned are used and registered in the United States of America.
4. CLOROX further covenants with GLAD to execute when requested such additional assignments, instruments and documents as may be necessary or desirable to effectuate this agreement and assignment.

IN WITNESS WHEREOF, the parties hereto have executed this Agreement as of this thirtieth day of June, 1999.
