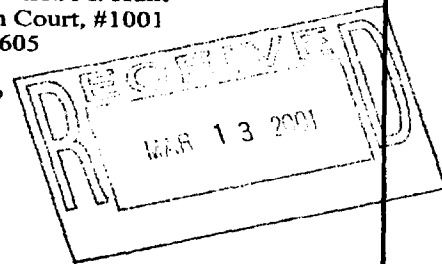

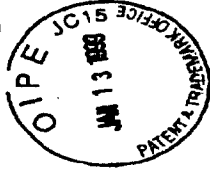


(d) All capitalized terms not otherwise defined in this Amendment No. 1 shall have the same meaning as given in the Security Agreement.




