TERMINATION OF TRADEMARK COLLATERAL ASSIGNMENT

This Termination of Trademark Collateral Assignment (hereinafter the "Termination of Assignment") is made as of the 9th day of April, 2001, and is made and executed by The Merchants Bank, a banking corporation with a place of business at 275 Kennedy Drive, South Burlington, Vermont 05403. This Termination of Assignment relates to that certain trademark registration No. 1130951 for the trademark VERMONT VELVET (hereinafter the "Trademark"), a Trademark owned by Rhino Foods, Inc., a Vermont corporation with its principal place of business at 79 Industrial Parkway, Burlington, Vermont 05401 and is as follows:

WHEREAS, on October 12, 1995, Rhino Foods, Inc., made, executed and delivered to The Merchants Bank that certain trademark collateral assignment (the "Collateral Assignment") which provided for the assignment of certain collateral, namely Rhino's trademark registration No. 1130951 for the Trademark; and

WHEREAS, the Collateral Assignment provided by its terms for a termination of the assignment and all interests of The Merchants Bank in and to the Trademark upon full payment and satisfaction of the obligations of Rhino Foods, Inc. to The Merchants Bank; and

WHEREAS, by this instrument, The Merchants Bank hereby acknowledges the full and complete satisfaction of all obligations owed to it by Rhino Foods, Inc.

NOW THEREFORE, intending to be bound, The Merchants Bank hereby terminates the Collateral Assignment and further, assigns and reassigns to Rhino Foods, Inc. *nunc pro tunc* all right, title and interest in the United States in and to the Trademark VERMONT VELVET
