

ASSIGNMENT OF TRADEMARKS AND TRADE NAMES

The entire and exclusive right, title and interest in and to the marks together with the goodwill of the business symbolized by the marks and the applications and registrations listed above and all claims and rights associated therewith, including the right to bring and maintain actions based on the trademarks and the right to register the marks to Assignee's name throughout the world; and
2. The sole right to enforce rights in said marks with the right to sue for and recover for Assignee's own use accrued profits or damages for any and all causes of action, claims and demands and other rights for infringements thereof, including, but not limited to past infringements with respect to which Assignor waives any right to receive any portion thereof.
