

RESTATED ARTICLES OF INCORPORATION

ARTICLE I: The name of this corporation is Barenbrug USA Inc.

ARTICLE II: The aggregate number of shares which the corporation shall have the authority to issue is 5,000 shares.

ARTICLE III: The board of directors of the corporation shall have the sole power and authority to manage and regulate the affairs of the corporation; provided that if the corporation and all shareholders shall execute a shareholders agreement otherwise defining, limiting, and regulating the powers of the corporation, its board of directors and shareholders, that agreement shall be binding on the corporation, its board of directors, its shareholders and all persons dealing with the corporation.

ARTICLE IV: The corporation shall advance all costs of defense and shall indemnify to the fullest extent permitted by the Oregon Business Corporation Act any person who has been made, or is threatened to be made, a party to an action, suit or proceeding, whether civil, criminal, administrative, investigative, or otherwise (including an action, suit or proceeding by or in the right of the corporation), by reason of the fact that the person is or was a director or officer of the corporation, or a fiduciary within the meaning of the Employee Retirement Income Security Act of 1974 with respect to an employee benefit plan of the corporation, or serves or served at the request of the corporation as a director, or an as officer, or as a fiduciary of an employee benefit plan, of another corporation, partnership, joint venture, trust, or other enterprise.
