

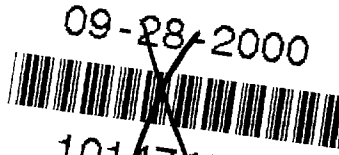



**RELEASE OF
COLLATERAL ASSIGNMENT OF TRADEMARKS**

THIS RELEASE OF COLLATERAL ASSIGNMENT OF TRADEMARKS

("Release") is made as of the 1st day of August, 2000 by LaSalle National Bank now known as LaSalle Bank National Association **("LaSalle")**.

RECITALS:

A. LaSalle and T and D Metal Products Co. (T&D") entered into a certain Collateral Assignment of Trademarks dated August 27, 1992, which document was filed with the U.S. Patent and Trademark Office at Reel 0905 Frame 835 (the **"Assignment"**).

B.
