

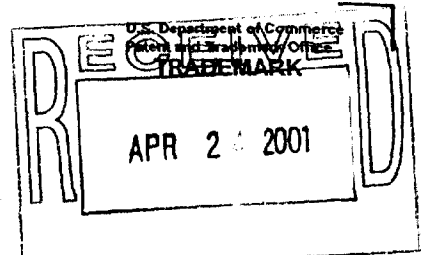




2. Article I of the Certificate is amended and restated in its entirety to read as follows:
