STATEMENT.

To all whom it may concern:

Be it known that E. F. Houghton & Co., a corporation duly organized under the laws of the State of Pennsylvania, located and doing business at Third, American, and Somerset streets, in the city of Philadelphia, in said State, has adopted and used the trade-mark shown in the accompanying drawing.

The trade mark has been continuously used in the business of said corporation, and in the business of its predecessors, E. F. Houghton & Co., since 1870, and applicant is the owner of registration No. 102,104, dated January 26th, 1915.

The merchandise to which this trade mark is appropriated is comprised in Class 15, Oils and greases; and the particular description of goods in said class upon which the trade mark is used is lubricating oils.

The trade mark is usually displayed by stenciling it upon the packages containing the goods, although it may be displayed upon labels to be attached to said packages or otherwise as desired.
