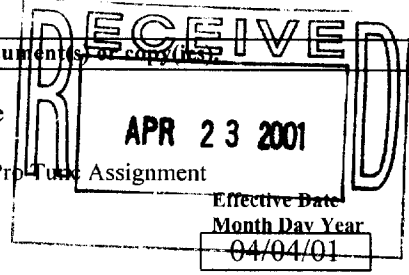



NUNC PRO TUNC ASSIGNMENT OF
TRADEMARK AND ACCOMPANYING GOODWILL

This assignment is made nunc pro tunc, effective September 16, 1998, between Chemphar Inc., a South Carolina company whose address is 2969 Wagener Road, Aiken, South Carolina 29801 ("Assignor"), and Nature's Own, Inc., a South Carolina company whose address is 3510 Richland Avenue, West, Aiken, South Carolina 29803 ("Assignee").


