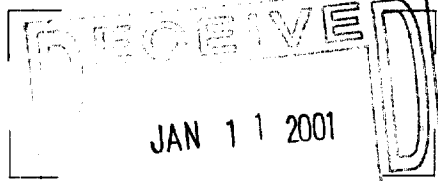

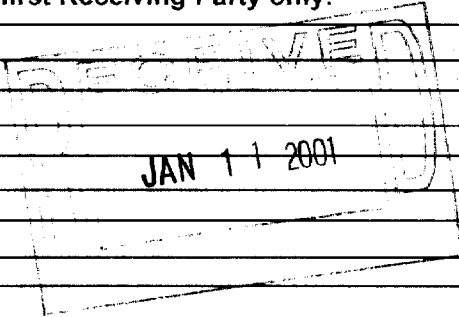

Notice of Release of Lien on Trademarks

This Notice of Release of Lien on Trademarks (the "Release") is executed this 17<sup>th</sup> day of December, 2000 by Citibank, N.A., a national banking association, as agent ("Agent") for the financial institutions party to the Credit Agreement dated as of May 20, 1994, among Barnett Inc., WOC Inc., Waxman Consumer Products Group Inc., Waxman USA Inc., the financial institutions party thereto and the Agent, in favor of WOC Inc., a Delaware corporation ("Grantor").

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Agent does hereby acknowledge the release, relinquishment and discharge of its security interest in, to and under the Released Trademarks.


