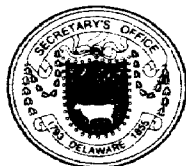

1. The constituent corporations participating in the merger herein certified are:
  - (i) CONAGRA GROCERY PRODUCTS COMPANY, which is incorporated under the laws of the State of Delaware; and
  - (ii) INTERNATIONAL HOME FOODS, INC., which is incorporated under the laws of the State of Delaware.
2. An Agreement of Merger has been approved, adopted, certified, executed, and acknowledged by each of the aforesaid constituent corporations in accordance with the provisions of subsection (c) of Section 251 of the General Corporation Law of the State of Delaware.
