## EXHIBIT A

### ASSIGNMENT OF "INSIGHT" TRADEMARK

ASSIGNMENT made this 20th day of December 2000 by and between Ingersoll-Rand Company ("Assignee"), a New Jersey corporation having its principal place of business at 200 Chestnut Ridge Road, Woodcliff Lake, New Jersey 07675 and Ingersoll Cinetic Automation Corporation ("Assignor"), a Delaware corporation having its principal place of business at 23400 Halsted Road, Farmington Hills, Michigan 48335.

WHEREAS, Assignor owns and has used, or is using, the "Insight" trademark (the "Mark") in the United States and throughout the world including U.S. Federal Serial No. 75-433727 and all common law rights.

WHEREAS, Assignor owns the U.S. and corresponding foreign trademark registrations for the Mark.

WHEREAS, Assignee is desirous of acquiring the Mark together with all rights therein, including the goodwill of the business associated therewith, as well as the U.S. Federal and corresponding foreign registrations identified therefore.

NOW, THEREFORE, in consideration of One Dollar (U.S.) and other valuable consideration, the receipt of and sufficiency of which is hereby acknowledged, Assignor hereby conveys, transfers, and assigns to Assignee all its rights, title, and interest in and to the Mark and the U.S. federal registrations and applications identified therefore, together with the goodwill of the business symbolized thereby, as well as the corresponding foreign trademark applications and registrations.

Assignor further assigns to Assignee all rights to sue for and receive all damages occurring from past infringing uses of the Mark.

Assignor warrants that it has good and valid title to the Mark, including the registrations therefore.

This Assignment shall be binding on the parties, their successors and/or assigns and all others acting by, through, with, or under their direction, and all those in privity therewith.

Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States, and any official of any country or countries foreign to the United States whose duty it is to issue registrations on trademark and service mark applications, to issue any and all Certificates of Registration on said applications, and on any renewal applications therefore, to Ingersoll-Rand Company as Assignee of the entire interest. Assignor hereby covenants that it has full right to convey the entire interests herein assigned, and that it has not executed, and will not execute, any agreements inconsistent herewith.

I hereby declare that all statements made herein of my own knowledge are true and that all statements made on information and belief are believed to be true; and further that these statements were made with the knowledge that willful false statements and the like so made are punishable by fine or imprisonment, or both, under Section 1001 of Title 18 of the United States Code and that such willful false statements may jeopardize the validity of the present trademark.
