SUPPLEMENTAL DEED OF ASSIGNMENT

BETWEEN:-

BASS MACHINE HOLDINGS LIMITED (company no. 3211009), a company incorporated in England whose registered office is at 20 North Audley Street, London, W1Y 1WE (*BMH*); and

BRANDBREW S.A. (company no. 478,821), a company incorporated in Luxembourg whose registered office is at Rue Carlo Hemmer, 4 L-1734, Luxembourg (*Brandbrew*).

WHEREAS:

- (A) BMH and Brandbrew are parties to an assignment agreement dated 22 August 2000 by which BMH assigned various intellectual property rights to Brandbrew (the *Assignment*).
- (B) The parties intended to assign the trade mark HOOPER'S HOOCH ICE as set out in the schedule to this Deed (the *Trade Mark*) under the Assignment but the Trade Mark was omitted from the schedule to the Assignment.
- (C) BMH has agreed to assign the Trade Mark to Brandbrew as set out in this Deed.

IT IS AGREED AS FOLLOWS:

ASSIGNMENT

- 1. The Assignor hereby assigns to the Assignee, subject to all terms and conditions of the Assignment and of any licences granted to third parties, all its right, title and interest in and to the Trade Mark, together with any goodwill and all statutory and common law rights attaching thereto including the right to sue for damages and other remedies in respect of any infringement or misuse of the Trade Mark which may have occurred prior to the date of this Deed and to retain any damages obtained as a result of any such action.

COUNTERPARTS

- 2. This Deed may be entered into in any number of counterparts and by the parties to it on separate counterparts, each of which is an original but all of which together constitute one and the same instrument.

GOVERNING LAW AND JURISDICTION


- 3.1 This Deed and the relationship between the parties shall be governed by, and interpreted in accordance with, English law.

3.2 Each of the parties agrees that the courts of England are to have exclusive jurisdiction to settle any disputes (including claims for set-off and counterclaims) which may arise in connection with the creation, validity, effect, interpretation or performance of, or the legal relationships established by, this Deed or otherwise arising in connection with this Deed, and for such purposes irrevocably submit to the jurisdiction of the English courts.


