OF COLLATERAL ASSIGNMENT



Grantor hereby acknowledges that TBCC's security interest and the term "Collateral" shall hereafter consist only of all equipment and other assets set forth on the schedules listing equipment or other assets (collectively such schedules referred to as "Schedules" or "Equipment Schedules") delivered from time to time under the terms of the Loan and Security Agreement (in that event, the "Equipment"), together with all present and future additions, parts, accessories, attachments, substitutions, repairs, improvements, and replacements thereof or thereto, and any and all proceeds thereof, including, without limitation, proceeds of insurance and all manuals, blueprints, know-how, warranties, and records in connection therewith, all rights against suppliers, warrantors, manufacturers, sellers, or others in connection therewith, and together with all substitutes for any of the foregoing.

TBCC does hereby further authorize and consent that this Acknowledgment of Termination will be filed for recordation and indexed by the Commissioner of Patents and Trademarks.
