RELEASE OF SECURITY INTEREST

BE IT KNOWN that the undersigned, **NEW DANA PERFUMES CORPORATION**, (as **Successor-in-Interest to New Fragrance License Corp.**) a Delaware corporation with its principal place of business at 479 Oakhill Road, Mountaintop, PA. 18707-2112 (the "Secured Party") for its benefit as a secured party to a certain Assignment for Security Interest between Secured Party and **HOUBIGANT, INC.**, dated July 1, 1994 and recorded at the United States Patent and Trademark Office on July 11, 1994 at REEL 1180, FRAME 0318 (the "Security Agreement") and the presently record holder of a security interest granted by **HOUBIGANT, INC.** (the "Grantor"), a Delaware corporation with its principal place of business at 333 East 68th Street, Suite 13A, New York, New York 10021, pursuant to the Security Agreement for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, does hereby fully, completely and without reservation of any kind, discharge, release and relinquish the Grantor, its successors and assigns, for the security interest held by Secured Party insofar as it related to all of Secured Party's right, title and interest in and to the trademark applications or registrations listed on the attached Schedule A together with the goodwill associated with the trademarks.

Should the Grantor so desire, Secured Party shall execute a UCC-3 Financing Statement Change and other such documents as may be appropriate releasing the collateral described above.

This Release should be governed by and construed in accordance with the laws of the State of New York.

Any amendment or modification of this Release must be made in a separate writing by Secured Party.
