**NUNC PRO TUNC ASSIGNMENT
OF U.S. TRADEMARK REGISTRATION 1,873,478**

WHEREAS, PMC SPECIALTIES GROUP, INC., having a place of business at 20525 Center Ridge Road, Rocky River, Ohio 44117 (hereinafter referred to as "PMC") was the owner of United States Trademark Registration No. 1,873,478, registered January 1, 1995, for the mark "REJEX-IT" (hereinafter "the Trademark"), and the goodwill of the business symbolized by the Trademark;

WHEREAS, PMC and B-U are desirous of making this Assignment a matter of record in the United States Patent and Trademark Office.

NOW, THEREFORE, for good and valuable consideration, the full receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, PMC hereby acknowledges that it did on November 30, 1999, sell, assign, transfer and convey unto B-U all of its right, title and interest in the Trademark in connection with animal repellents, including any choses in action relating to the Trademark in connection with animal repellents, claims for damages, profits and costs, both in equity and law, for any infringement or infringements of the Trademark in connection with animal repellents accruing on or before the date of this Assignment, together with the goodwill of the business symbolized by the Trademark in connection with animal repellents, and including the registration thereof as set forth above; and further, PMC hereby covenants, agrees and

undertakes to execute, whenever requested by B-U, all applications, assignments, lawful oaths and any other papers which B-U may deem necessary or desirable for securing to B-U or for maintaining for B-U the Trademark in connection with animal repellents, hereby acknowledged to have been assigned, and the choses in action therefor, all without further compensation to PMC.

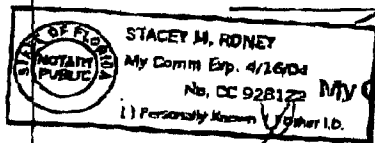
