TRADEMARK COLLATERAL**


Reference is hereby made to that certain Trademark Collateral Security and Pledge Agreement between Tartan Textile Services, Inc., a Delaware corporation ("**Assignor**"), and Fleet National Bank, a national banking association ("**Agent**"), as agent for itself and certain other lending institutions, executed on September 29, 2000, which was recorded in the United States Patent and Trademark Office on October 10, 2000, at reel/frame 002174/0164 ("**Security Agreement**") and pursuant to which Assignor granted and pledged to Agent a security interest in, lien on and mortgage on, and conditionally assigned, transferred and conveyed to Agent, the Pledged Trademarks (as defined in the Security Agreement), including without limitation all of Assignor's right, title and interest of in and to the applications for registration of trademark (and any trademarks issuing thereon) listed on Schedule A hereto (the "**Pledged Trademark Registrations**").

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby releases and terminates any and all security interests, liens and any other rights or interest it may have in the Pledged Trademarks, including without limitation the Pledged Trademark Registrations, and reassigns to Assignor all of its right, title and interest in the Pledged Trademarks, including without limitation the Pledged Trademark Registrations.

Agent represents and warrants to Assignor that it has in no way conveyed, granted, transferred, encumbered, hypothecated or otherwise pledged or disposed of any of the rights, title or interest granted to Agent under the Security Agreement to any party other than Assignor.
