BE IT ACKNOWLEDGED that:

'21' CLUB, INC., having an address c/o Orient-Express Hotels Inc., 1155 Avenue of the Americas, New York, New York 10036 ("Debtor") hereby grants to OVERSEA-CHINESE BANKING CORPORATION LIMITED, NEW YORK AGENCY, having an address at Two World Financial Center, 225 Liberty Street, 36th Floor, New York, New York 10281, and its successors and assigns ("Secured Party") a security interest in, and a lien on, all of the trademarks set forth on Schedule A attached hereto (the "Trademarks") to the fullest extent permitted by the Uniform Commercial Code.

This security interest is made pursuant to a certain Security Agreement, dated March 2, 2001, made by Debtor in favor of the Secured Party (the "Security Agreement") in order to secure the Secured Obligations, as defined in the Security Agreement in the aggregate principal amount of US\$15,000.000.00, and this Trademark Security Agreement.
