

TRADEMARK ASSIGNMENT

WHEREAS, Huhtamaki Foodservice, Inc. ("Huhtamaki"), a corporation duly organized under the laws of the State of Delaware, and having its principal place of business at 242 College Avenue, Waterville, County of Kennebec, and State of Maine, desires to sell its entire right, title and interest in the trademarks, corresponding trademark applications and registrations, and common law, unregistered trademarks, including the goodwill of the business symbolized thereby and associated therewith, as set forth in Schedule A attached hereto and incorporated herein (hereinafter "the Marks");

WHEREAS, Keyes Fibre Corporation ("Keyes"), a corporation duly organized under the laws of the State of Delaware, and having its principal place of business at 3715 Chelan Highway, Wenatchee, County of Chelan, and State of Washington 98801, is desirous of acquiring said Marks;

WHEREAS, Huhtamaki may have rights in the Marks through its prior use, or prior use by its subsidiaries or affiliates of these Marks, and Huhtamaki is providing this Assignment without any representation or warranty concerning possible third party use of the Marks or the registration status of the Marks;

NOW, THEREFORE, to all whom it may concern, be it known that for good and valuable consideration, including consideration previously transferred, the receipt and sufficiency of which are hereby acknowledged, Huhtamaki has sold, assigned and transferred, and by these presents does sell, assign and transfer unto said Keyes the full and exclusive right, title and interest, throughout the United States and Canada, in and to the Marks, to the extent Huhtamaki or any of its predecessors or affiliates has rights in said Marks, together with the goodwill of the business symbolized by the Marks, and the above identified registrations thereof, and the right to recover for any past infringement of said Marks, subject to the rights of CKF, Inc. as provided in the 1978 and 1979 Agreements between Keyes Fibre Company of Maine and Canadian Keyes Fibre Company Limited of Canada, and the rights of the real estate investment company, Revere Keyes, a Delaware company and an affiliate of Huhtamaki, to continue to use the "Revere Keyes" name in this format only and only as a corporate name used in connection with real estate investment services.
