Release of Trademark Security Agreement

THIS RELEASE is entered into between **American National Bank and Trust Company of Chicago**, (the "Lender"), with offices at 120 S. La Salle Street, Chicago, Illinois and **Sprague Devices, Inc.**, an Indiana corporation (the "Borrower"), with offices at 107 Eastwood Road, Michigan City, Indiana.

Witnesseth:

WHEREAS, Borrower is the owner of the trademarks set forth on Exhibit A, ("Trademark Rights"); and

WHEREAS, pursuant to a certain Agreement by and between Borrower and Lender, Borrower granted a continuing security interest to Lender in certain assets, including the Trademark Rights; and

WHEREAS, a certain Security Agreement was recorded with the U.S. Patent and Trademark Office on September 18, 1986, at Reel 0538, Frame 0254 ("Security Agreement"), with respect to the Trademark Rights; and

WHEREAS, Borrower has fully repaid Lender, Lender has released and discharged Borrower from the terms and conditions set forth in said Security Agreement, and the parties wish to record with the U.S. Patent and Trademark Office the release of security interest against the Trademark Rights.

NOW, THEREFORE, Lender (i) hereby releases all of its security interests in the Trademark Rights and hereby transfers and assigns to Borrower all of its right, title and interest in and to the Trademark Rights; and (ii) has caused this Release of Trademark Security Agreement to be duly executed this 27 day of March, 2000.

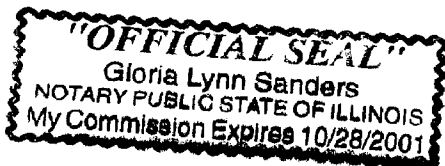
