

Bill of Sale and Assignment
(Intellectual Property)

THIS BILL OF SALE is executed as of March 27, 2001, by Tri Valley Growers, a California nonprofit agricultural cooperative and Debtor and Debtor-in-Possession under Case No. 00-44089-J-11 in the United States Bankruptcy Court for the Northern District of California, Oakland Division ("Grantor"), in favor of Signature Fruit Company, LLC, a Delaware limited liability company ("Grantee").

FOR VALUE RECEIVED, receipt of which is hereby acknowledged, Grantor does hereby grant, bargain, sell, convey, assign, transfer and set over unto Grantee, absolutely and not as security, all of Grantor's right, title and interest in and to the following, whether now existing or hereafter arising, acquired or created:

a. All copyrights, patents, trademarks, trade names, logos, trade styles and service marks, and all prints and labels on which said trademarks, trade names, logos, trade styles and service marks have appeared or appear, and all designs and general intangibles of like nature trade secrets, inventions, know how, other confidential information and other intellectual property, all right, title and interest therein and thereto, all registrations and recordings thereof, including, without limitation, (i) all applications, registrations and recordings in the Patent and Trademark Office or in any similar office or agency of the United States, any state thereof, or any foreign country or any political subdivision thereof, all whether now owned or hereafter acquired by Grantor, including, without limitation, those described in Attachment A, which Attachment A is incorporated herein by this reference, and (ii) all reissues, extensions or renewals thereof and all licenses thereof (collectively, the "Intellectual Property");

b. All goodwill of Grantor's business symbolized by, incorporated in or associated with the Intellectual Property and all customer lists and other records of Grantor relating to the distribution of products or provision of services bearing or covered by the Intellectual Property;

c. All claims by Grantor against any individual, corporation, partnership, association, trust, government or political subdivision or agent or instrumentality thereof, or other entity or organization for past, present or future infringement of the Intellectual Property; and


