## CONDITIONAL ASSIGNMENT

WHEREAS, Procesadora Campofresco, Inc., a corporation of Puerto Rico having its principal place of business at State Road 545, km. 0.3, Paso Seco Ward, Santa Isabel, Puerto Rico 00757, with a mailing address P.O. BOX 755, Santa Isabel, Puerto Rico 00757 (hereinafter "Procesadora"), has used, is using and is the owner of the trademarks, applications and registrations listed in the schedule attached hereto as Appendix A, and is the owner by assignment of the common law and concurrent use rights in Puerto Rico in the marks listed in Exhibit A to the Concurrent Use Agreement attached hereto as Appendix B, including the goodwill symbolized by said marks; and

WHEREAS, Procesadora and Banco Bilbao Vizcaya-Puerto Rico, a Puerto Rican banking corporation having its principal place of business at BBV Plaza, 1510 F.D. Roosevelt Avenue, Guaynabo, Puerto Rico 00966 (hereinafter "Banco Bilbao"), entered into a Security Agreement (Term Loans) on October 30, 1998 (hereinafter "Security Agreement"), under which Procesadora has assigned to Banco Bilbao, *inter alia*, a security interest in the trademarks, applications and registrations of Procesadora listed in Appendix A and the common law and concurrent use rights in the marks listed in Exhibit A to the Concurrent Use Agreement attached hereto as Appendix B, which entitles Banco Bilbao to obtain an assignment of all of said trademarks under the Security Agreement upon the occurrence of an Event of Default (as such term is defined in the Credit Agreement (Term Loans) executed on October 30, 1998 by Procesadora and Banco Bilbao); and

NOW, THEREFORE, for and in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Procesadora hereby conditionally assigns all of its right, title and interest in and to the trademarks, applications and registration listed in Appendix A, and the common law and concurrent use rights in the marks listed in Exhibit A to the Concurrent Use Agreement attached hereto as Appendix B, together with the goodwill of Procesadora's business associated with said trademarks, to Banco Bilbao, said assignment being conditioned upon the occurrence of an Event of Default and Banco Bilbao's decision to foreclose on the Collateral (as such term is defined in the Security Agreement), upon which occurrence this conditional assignment shall become operative.
