

THIS ASSIGNMENT OF TRADE MARKS is made on 14th October, 1999

BETWEEN:

- (1) NDS LIMITED, a company organised and existing under the law of England under number 3080780, whose registered office is at 1 Heathrow Boulevard, 286 Bath Road, West Drayton, Middlesex, UB7 0DQ, United Kingdom ("NDS"); and
- (2) ORDINTO INVESTMENTS, (registered number 1246707) whose registered office is at P.O. Box 495, Virginia Street, London E1 9XY ("Ordinto")
- (3) TANDBERG TELEVISION LIMITED, a company organised and existing under the law of England under number 3695535, whose registered office is at 35 Basinghall Street, London, EC2V 5DB (the "Assignee").

WHEREAS

- (A) NDS is the proprietor of the registered trade marks and trade mark applications details of which are set out in the Schedule to this assignment (the "Marks").
- (B) By an agreement dated 1st July, 1999 between NDS and Ordinto as amended (the "Transfer Agreement") NDS has agreed to assign the Marks to Ordinto together with the goodwill of the Business attaching to the Marks.
- (C) NDS and Ordinto have used the Marks in their business of the manufacture and supply of digital compression equipment (the "Business").
- (D) By an agreement dated 8th October, 1999 (the "Agreement"), the Assignor agreed to assign the Marks to the Assignee together with the goodwill of the Business attaching to the Marks.
- (E) The parties now wish to give effect to that Agreement by means of this Assignment.

IT IS AGREED as follows:

1. In consideration of the sum of £9,000 (nine thousand pounds) (receipt of which is hereby acknowledged), NDS hereby transfers at the direction of Ordinto and Ordinto hereby transfers to the Purchaser all the right, title and interest of NDS and Ordinto respectively in the Marks TO HOLD the same unto the Assignee absolutely.
2. This Assignment, all rights, privileges, and advantages relating to the Marks including without limitation, the right of the Assignee to bring action and claim relief (and retain any awards made) in respect of any infringement of the Marks whether occurring before, on, or after the date of this assignment.
3. Ordinto and NDS agree, at the request of the Assignee, to execute any further documents and do all things which may be necessary to give full effect to this assignment including, without limitation, to comply with local registry requirements for the recordal of the assignments of the Marks.
4. The Assignee acknowledges that neither NDS nor Ordinto, in this assignment, gives any indemnity, guarantee, representation or warranty in respect of the Marks.
