ASSIGNMENT OF TRADEMARKS**

This **ASSIGNMENT OF TRADEMARKS** (the "Assignment") is entered into this 1st day of May, 2001 by and between Primus Telecommunications Group, Inc., a Delaware corporation with its principal place of business at 1700 Old Meadow Road, McLean, Virginia 22102 ("Assignor") and Primus Telecommunications, Inc., a Delaware corporation with its principal place of business at 1700 Old Meadow Road, McLean, Virginia 22102 ("Assignee").

**WHEREAS**, Assignor owned various trademarks, which are identified on the Schedule of Trademarks attached hereto (the "Marks"), and pending trademark applications therefor in the United States and abroad;

**WHEREAS**, Assignee acquired all right, title and interest in and to the Marks, throughout the world, together with the goodwill of the business symbolized by the Marks from Assignor on January 1, 2001; and
