The name of the corporation shall be: Hickson Kerley, Inc.

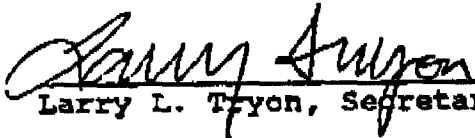
2. Except as expressly set forth above, all other terms and conditions of the Certificate of Incorporation remain in full force and effect.
