And for the above-named considerations, Assignor does hereby agree that, at the request of Assignee, execute any and all other papers and documents and do all other and further lawful acts that said Assignee may deem necessary or desirable to perfect and vest in the Assignee the entire right, title and interest in the Trademark.

And for the above-named considerations, Assignor does hereby authorize and empower the Assignee, its successors and assigns, to apply for and obtain, in their own names, protection for the Trademark before competent International Authorities and in any and all countries foreign to the United States in which applications can be so made or so obtained.
