Under Section 242 of the General Corporation Law

Screaming Media.Net, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "Corporation"), DOES HEREBY CERTIFY:

FIRST: The name of the corporation is Screaming Media.Net, Inc. and the original Certificate of Incorporation of the Corporation was filed with the Secretary of the State of Delaware on January 22, 1999.

SECOND: The amendment of the Certificate of Incorporation of the Corporation effected by this Certificate of Amendment of Certificate of Incorporation is (i) to change the name of the Corporation to Screaming Media.com Inc.; and (ii) to increase the number of shares of Common Stock the Corporation is authorized to issue to one hundred million (100,000,000) shares of Common Stock.

THIRD: To accomplish the foregoing amendment, the First Article of the Certificate of Incorporation of the Corporation, which sets forth the name of the Corporation, and the Fourth Article of the Certificate of Incorporation of the Corporation, relating to the capital structure of the Corporation, are hereby amended in their entirety to read as follows:

"FIRST: The name of the corporation is Screaming Media.com Inc." and

"FOURTH: The total number of shares of stock which the Corporation shall have authority to issue is one hundred five million (105,000,000) shares, consisting of two classes of stock with the following numbers of authorized shares of stock per class, all classes having a par value of \$0.01 per share: one hundred million (100,000,000) shares of Common Stock, and five million (5,000,000) shares of Preferred Stock, which may be issued from time to time in Series having such rights, preferences, designations and other terms and conditions as determined by resolution of the Board of Directors."


