Gentlemen:

The purpose of this letter is to confirm to you the following:

1. H/Q Vineyards LLC has changed its name to Huneus Vintners LLC;
2. H/Q Wines LLC will be consolidated with Huneus Vintners LLC, so there will be only one Huneus family entity for you to deal with; and
3. with your consent, that H/Q Wines LLC hereby assigns all of its right, title and interest in the following contracts to Huneus Vintners LLC:
 - (a) the Quintessa Distribution and Branded Inventory Purchase Agreement dated as of June 7, 1999;
 - (b) the Wine Processing Agreement dated as of June 4, 1999; and
 - (c) the ACSA Distribution Agreement, dated as of June 4, 1999.

Of course, the obligations of H/Q Vineyards LLC to you will remain unchanged by the change of its name to Huneus Vintners LLC.

As parties to one or more of the agreements referenced above, we ask that you please execute your acknowledgment and consent to these changes.
