ASSIGNMENT OF TRADEMARK


This ASSIGNMENT OF TRADEMARK ("this Assignment") is effective as of January 1, 2001 between Verizon Communications Inc. (by merger and change of name from Bell Atlantic Corporation), a corporation organized and existing under the laws of Delaware, having a place of business at 1095 Avenue of the Americas, New York, New York 10036 (hereinafter "ASSIGNOR"), and Cellco Partnership, a general partnership organized and existing under the laws of Delaware, doing business as Verizon Wireless, having a place of business at 180 Washington Valley Road, Bedminster, New Jersey 07921-2120 (hereinafter "ASSIGNEE").

WHEREAS, ASSIGNOR adopted and used in the United States of America the trademark MOBILE MESSENGER, which is the subject of United States Trademark Registration No. 1,846,918 issued July 26, 1994; and

WHEREAS, on January 1, 2001, ASSIGNOR conveyed unto ASSIGNEE all rights, title and interest in and to the aforesaid trademark in the United States of America, together with the goodwill of the business symbolized by the trademark and the aforesaid trademark registration, together with the right to recover damages for any past and future acts of infringement, and is now desirous of confirming and making of record said conveyance.

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, ASSIGNOR confirms that it assigned unto ASSIGNEE all rights, title and interest in and to the aforesaid trademark in the United States of America, together with the goodwill of the business symbolized by the trademark, and the aforesaid trademark registration, together with the right to recover damages for any past and future acts of infringement, nunc pro tunc as of January 1, 2001.
