**ASSIGNMENT AND RELEASE OF
ASSIGNMENT FOR (TRADEMARKS AND TRADEMARK LICENSES)**

(TRADEMARKS)

RECITALS

A. Beringer Wine Estates Company (f/k/a Wine World Estates Company), a Delaware corporation ("Beringer"), as Grantor, and American AgCredit, PCA (f/k/a Pacific Coast Farm Credit Services, ACA) ("AAC"), as Lender, entered into:

(i) that certain Assignment for Security (Trademarks and Trademark Licenses) dated as of January 16, 1996, and recorded with the U.S. Patent and Trademark Office on January 19, 1996, at Reel 1425, commencing at Frame 0004, with respect to Trademarks; and

(ii) that certain First Amendment to Assignment for Security (Trademarks and Trademark Licenses) dated as of April 1, 1996, and recorded with the U.S. Patent and Trademark Office on April 2, 1996, at Reel 1465, commencing at Frame 0226 with respect to Trademarks;

(iii) that certain Second Amendment to Assignment for Security (Trademarks and Trademark Licenses) dated as of February 28, 1997, and recorded with the U.S. Patent and Trademark Office on March 11, 1997, at Reel 1567, commencing at Frame 0594 with respect to Trademarks; and

(iv) that certain Third Amendment to Assignment for Security (Trademarks and Trademark Licenses) dated as of September 14, 1999, and recorded with the U.S. Patent and Trademark Office on October 8, 1999, at Reel 001974, commencing at Frame 0869 with respect to Trademarks;

pursuant to which Beringer granted to AAC a security interest in and lien on all of its interest in and to the Intellectual Property Collateral (as defined therein).


B. AAC desires to release its security interest in and lien on the Intellectual Property Collateral.
