2. Article 1 of the Company's Articles of Organization is hereby amended to read in its entirety as follows:

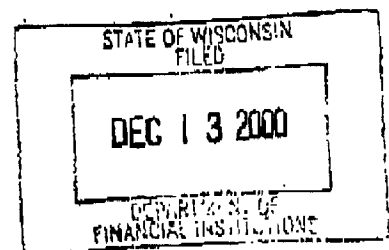
"Name of Limited Liability Company: CERAbio LLC."
