TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT is made and delivered this 10th day of January, 2001, by TRICOTS ST. RAPHAEL, INC., a New York corporation ("SELLER"), and SALANT HOLDING CORPORATION, a Delaware corporation (hereinafter referred to as "BUYER"), pursuant to the Asset Purchase Agreement dated as of December 20, 2000, between SELLER, BUYER, and CECILE PLATOVSKY (the "Asset Purchase Agreement"; capitalized terms not defined herein have the meanings ascribed to them in the Asset Purchase Agreement).

WITNESSETH, THAT FOR AND IN CONSIDERATION of the mutual promises contained in the Asset Purchase Agreement, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by SELLER, and pursuant to the Asset Purchase Agreement, SELLER HEREBY bargains, sells, grants, assigns, transfers, conveys and delivers unto BUYER, its successors and assigns:

(i) All of SELLER's right, title and interest in and to the trademarks listed on Schedule 1 attached hereto; and

(ii) All of SELLER'S right, title and interest in and to all statutory, common law and registered copyrights, trademarks, service marks and tradenames (including registrations and applications for registration or any of the foregoing), and all trade secrets, designs, logos, and other intangible rights and interests, if any, owned by SELLER on the date hereof and primarily used in the Business other than those listed on Schedule 1 attached hereto.

(iii) The good will of the Business and all good will with respect to the items described in (i) and (ii) above.

TO HAVE AND TO HOLD the same unto BUYER, its successors and assigns forever.

IN ADDITION, from time to time after the date hereof, without further consideration, SELLER shall, at no cost or expense to Seller, execute and deliver such other instruments of assignment, transfer and conveyance and shall take such other action as BUYER may reasonably request in order more effectively to assign, transfer and convey to BUYER, and to place BUYER in possession and control of, any of the property being assigned, transferred and conveyed to it hereunder, or to enable it to exercise and enjoy all rights and benefits of SELLER with respect thereto.


